- An organ of state must, upon detecting that a preference in terms of the Act and these regulations has been obtained on a fraudulent basis, or any specified goals are not attained the performance of the contract, act against the person awarded the contract.
 - (3) An organ of state may, in addition to any other remedy it may have against the person contemplated in sub-regulations (1) –
