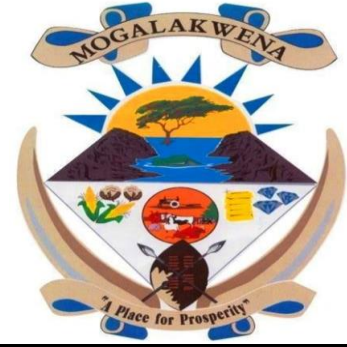

"Acceptable bid" means any bid which, in all respects, complies with the conditions of bid and specifications as set out in the bid documents.

A BID WILL BE REJECTED:

1. 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (b) Specific Goals.
