Tenders are hereby invited from prospective tenderers for the construction of the “Mokopane- High to Piet-se-Kop Pipeline” which is part of the development of the Olifants River Water Resources Development Project (ORWRDP) - Integrated Water Supply System - Mogalakwena Local Municipality in the Waterberg District of the Limpopo Province. The proposed scope of work will entail the collection and supply of material and construction of the following:

- 2.9km x 800ND welded steel pipeline. Pipes to be provided by municipality.
- 5.0km x 630ND and 520m x 500ND PVC pipeline.
- Rail, road and river crossings
- Pipe Jacking (approx. 60m).
- Associated valves, valve chambers and manholes
- Connection into reservoir.

The construction site is situated on the eastern side of the town of Mokopane.

Qualified contractors are only those that have a CIDB class designation suited to the Tender Value which is estimated to be **8 CE** or an equal joint venture rating or higher. Only contractors with proven expertise in the required fields should tender. A tender condition is that the participation of local contractors from the Mogalakwena Municipality be at least 25%.

The employer is the **MOGALAKWENA LOCAL MUNICIPALITY**.

Tender documents are obtainable from the Mogalakwena Local Municipal offices upon receipt of a non-refundable cash or bank guaranteed cheque payment of R1 000-00 per set. The municipality shall evaluate and award the tender in accordance with the procurement policy of the municipality and the CIDB guidelines on a point scoring system for preferences, quality and price.
