- Quotations must be accompanied by <u>valid Tax clearance certificate</u>; <u>CK/Company registration certificate</u>, <u>B-BBEE status level certificate</u> <u>from an accredited agency, auditors or accountants</u>, <u>MBD 1, MBD 4</u>, <u>MBD 6.1</u> and <u>MBD 8</u> forms obtainable on the Municipal website and procurement office (stores)
- Fixed prices must be valid for thirty (30) days.
- Bidders MUST quote on balance rates as the quantity of some items can be reduced due to budget constraints.
- The brand name of the offered items must be clear on the quotation so as the municipality is certain of what to expect on/after approval of the quotation.
- Goods must be SABS approved.
- VAT MUST BE LEVIED BY VAT REGISTERED SUPPLIERS ONLY.
- Suppliers must be in a position to deliver within 14 days upon receipt of official order.

Quotations will be evaluated on an 80/20 point system. Whereas 80 points will be for price and 20 for preference as per PPPFA 2000, BBBEEA 2003 and preferential procurement regulations 2011.
