# PART C3: SCOPE OF WORK

# Location of the works

The sanitation services will be provided in the jurisdiction of Mogalakwena Local Municipality.

# Brief description of the works

Appointed service provider will provide sanitation services by provision and servicing of mobile toilets, draining of septic tanks and manholes and high pressure jetting/vacuuming.

# Works specification

- New mobile toilets will be procured as and when required, such supplied toilets will not incur hiring cost and may only incur servicing costs.
- All hired toilets will be hygienically clean at all times, marked and be safely placed at required and agreed position. Trailer toilets are to be safely secured.
- Service interval for long-term hire shall be as per agreement with the municipality taking into account the acceptable environment for the users.
- Event hired mobile toilets shall be made available and delivered to the event venue prior to the start of the event. Special protocols will be observed for special event in accordance to SAPS/Security requirements. The toilets shall be removed immediately after the event.
- Provided portable mobile toilets are to be of plastic or equivalent material (metallic toilets will not be acceptable).
- The mobile toilets are at all times to have the required non-harmful chemicals. After servicing of chemicals, the sewer will be disposed at Mokopane WWTW or Rebone WWTW.

- Sewer tanker (honeysucker) shall be hired as and when required and shall include the
  cost of the driver and assistant. The truck shall dispose sewer at the Mokopane WWTW
  and such proof will be required. All safety protocols to be observed during works and
  transportation.
- High pressure vacuum/jetting services shall be as and when required and the cost shall include all required personnel and equipment. No additional cost shall be paid. All safety protocols to be observed during works and transportation.
- Prices are to include all required, no additional amount will be paid beyond the tendered or negotiated rates.
- COVID-19 protocols to be observed by the appointed service provider during delivery and conducting of works.
- A successful bidder will be required to open an account with the Mogalakwena Local Municipality for sewer disposal and pay all the required deposit.
