Regulation 15 of the Preferential Procurement Policy provides as follows:

- An organ of state must, upon detecting that a preference in terms of the Act and these regulations has been obtained on a fraudulent basis, or any specified goals are not attained the performance of the contract, act against the person awarded the contract.

- (a) recover all costs, losses or damages it has incurred or suffered as a result of that person's conduct;
