SPECIFICATION FOR MOGALAKWENA MUNICIPALITY EMERGENCY EVACUATION SYSTEM

PURPOSE

To enable employees, clients, visitors, contractors etc to effectively respond to any emergency that might require evacuation of the premises.

COMPONENTS OF THE SYSTEM SHOULD INCLUDE:

Public address and Voice Alarm

- INPUTS (Fire mic; Fire Alarm; Paging mic; Voice alarm)
- AMPLIFIERS
- NOISE SENSORING
- 1. **INITIATING DEVICES** To activate fire alarm when the smoke detector goes off or the fire alarm panic button is activated.
- 2. **NOTIFICATION DEVICES**-To allow effective communication by the speaker through the mic and announcement.

- TO BE DIVIDED INTO COLOR CODED ZONE-To ensure proper monitoring and to allow identification of specific location during emergency.
- 4. **FAULT MONITORING DEVICE**-To indicate fault or errors within the layout diagram of the system. E.g. Stand-by power supply.
- 5. **TROUBLE SHOOTING**(FAULTS REPORTING)
- 6. **MAPPING LAYOUT** That provides a layout diagram clearly identifying the entire system in zones.
- 7. BATTERY BACK-UP
- 8. **FIRE INTERFACE**-(INITIATING DEVICE)
- 9. EMERGENCY BOARD INDICATOR WITH COLOR CODED SIGNALS
- 9.1 ACTIVATED SMOKE DETECTOR
- 9.2 ACTIVATED FIRE ALARM
- 9.3 AFFECTED ZONE AREA

- No pricing option is allowed. Only one price for one brand must be supplied.
- Please indicate the brand which is quoted and that which will be delivered.
- Only locally produced or locally manufactured textiles, clothing, leather and footwear from local, raw material or input will be considered.
- The exchange rate to be used for the calculation of local production and content must the exchange rate published by the South African Reserve Bank (SARB) at 12:00 on the date of advertisement of the bid.
- SABS approved technical specification number SATS 1286:2011will be used to calculate local content.
- All awards are subject to the user division confirming the sample.
- Only firm prices will be accepted, non-firm prices (including prices subject to rates of exchange variations) will not be considered.
- Fixed prices must be valid for thirty (30) days.
- VAT MUST BE LEVIED BY VAT REGISTERED SUPPLIERS ONLY.
