**3. SETTLEMENT OF LEGAL ACTIONS BETWEEN S W KEKANA /
MOGALAKWENA LOCAL MUNICIPALITY (15/3/2/60)I
(ITEM 3 AGENDA SPECIAL EC 4 JUNE 2013)**

The municipal manager recused himself and Mr L F Masibe was appointed to act as municipal manager.

The mayor read out the recommendations of the executive committee.

The acting municipal manager advised council regarding the provisions of section 117 of the MFMA.

Councillor M F Maritz proposed that a secret ballot voting be held in respect of the approval or not of the recommendations of the executive committee and councillor K Q Dekker seconded him.

Councillors G E Morkel-Brink, T A Kgaphola, M W Mabuela, M I Mogotlane and F M Mabuela requested that their names be recorded against the recommendations of the executive committee.

A secret ballot voting was held, 28 councillors in favour of the recommendations of the executive committee and 33 voted against the recommendations.

Councillor D P Motlohoneng proposed that a secret ballot voting be held with regard to the implementation of the letter from the MEC of COGHSTA and councillor G E Morkel-Brink seconded him.

A secret ballot voting was held, 18 councillors voted for the proposal and 41 voted against the proposal.

Councillors G E Morkel-Brink, L S Molomo, M A Sekoala, COPE councillors and Democratic Alliance councillors requested that their names be recorded against the resolution.

THAT the report be referred to the executive committee for full finalization of the matter and report back to council for a decision.
