#### 3. TOWN PLANNING: ALLOCATION OF RESIDENTIAL ERVEN TO THE COMMUNITY OF BLACK ROCK ON PORTIONS OF MAHWELERENG <u>TOWNSHIP (UNIT A, B & C)</u> (17/3/4)SP (ITEM 3 AGENDA SPECIAL EC 31 MAY 2010)

## RESOLVED:

THAT

- a) the allocation of erven to the qualifying beneficiaries of Black Rock community be approved subject to the following conditions:
  - i) the manager: corporate support services be responsible for the allocation of erven;
  - ii) Town Planning section be responsible for the identification of beacons (pegs) of all erven;
  - iii) Deed of Grant (Proof of ownership) be submitted to the municipality in exchange of new residential or business erven;
  - iv) affected churches will also be allocated erven on the newly demarcated areas.
  - v) the municipality demolishes the structures at Black Rock as and when it is vacated.
- b) the municipality gives notice for a period of 28 working days on the affected area (Black Rock) notifying beneficiaries of the allocation of erven, including the responsible official, place and times when the allocation will start.
- c) deeds of grants be applied for in respect of low income beneficiaries.
- d) a meeting be arranged with affected beneficiaries to explain the process.
- e) it be noted that the exchange of erven is in full and final settlement and no claim can be instituted against the municipality for improvements that have been damaged by the soil conditions or the demolishing of the vacated structures.
- f) owners who have been provided with low cost houses also submit original deed of grants.
- g) all persons living in Bargain also be allocated erven in the same way and the erf prices be negotiated.

- b) in terms of section 14 of the Local Government: Municipal Property Rates Act, 2004 (Act 6 of 2004) (MPRA) the assessment rates reflected in Annexure A (pages 387 to 391 to the executive committee agenda dated 31 May 2010) be approved for the budget year 2010/11 and a further rebate be granted to limit the increase in rates for moving from the site rating system to the system of rating the total value of the property and in the event of such increase being 40% (forty percent) or more (between the rates that were payable on 30 June 2008 and on the rates that were payable on 1 July 2008- The property owner paid the first 40% in 2008/09 and the difference will be paid as follows:
  - i) the limit for the additional increase above 40% for the 2008/09 financial year is 25% of the difference.
  - ii) the limit for the additional increase above 40% for the 2009/10 financial year is 50% of the difference.
  - iii) the limit for the additional increase above 40% for the 2010/11 financial year is 75% of the difference.
  - iv) as from the 2011/12 financial year, full rates will be payable:

Provided that this rebate does not apply to an increase in rates owing to a supplementary valuation made in terms of section 78(1) of the MPRA.

- c) in terms of section 75A of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) the tariffs and charges reflected in Annexure B to G attached as <u>pages 392 to 402</u> to the special executive committee agenda dated 31 May 2010, be approved for the financial year 2010/11.
- d) in terms of section 75A of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) an average of 19% increase on the electricity tariffs as reflected in Annexure H attached as <u>pages 403 to 410</u> to the special executive committee agenda dated 31 May 2010, and subject to the approval of NERSA, be approved.
- e) the amended Tariff Policy attached as <u>pages 374 to 386</u>, the amended Rates Policy, Credit control and debt collection by-law, Indigent Policy, Investment and Cash Management Policy and Supply Chain Management Policy attached as <u>pages 411 to 505</u> to the special executive committee agenda dated 31 May 2010, be approved for the budget year 2010/11.
- f) the new asset management policy and asset management procedure attached as <u>pages 506 to 547</u> to the special executive committee agenda dated 31 May 2010, be approved for the budget year 2010/11.
- g) transfer of savings in respect of the operating budget be limited to expenditure within the same vote and expenditure category unless the mayor authorizes the transfer.

- h) the 2010/11 capital and operating budget be submitted to National Treasury and Provincial Treasury in both electronic and printed format immediately after tabling the budget.
- i) interest on all amounts in arrears be charged at the rate determined from time to time in terms of the provisions of the Prescribed Rate of Interest Act, 1975 (Act 54 of 1975) or any other relevant Act.
- j) it be noted that section 53(1)(c)(ii) of the MFMA provides that the Mayor must take all reasonable steps to ensure that the municipality's Service Delivery and Budget Implementation Plan is approved by the Mayor within 28 days after the approval of the budget.
- k) it be noted that the contracts for the re-gravelling of roads in the 3 SDA's will be terminated on 30 June 2011.
- I) it be noted that the blanket approach for free basic electricity to all will be terminated with the exception of indigents that will still receive the 50kwh:

from 1 July 2010 - 0 kwh for non-indigents

- m) it be noted that the final job evaluation results from SALGBC have not yet been issued to the municipality but the municipality has however, as a contingent measure, made provision on the budget for the implementation of the salaries in the 2010/11 budget year and final amendments will be done with the adjustment budget.
- n) it also be noted that there will no longer be any water tankering from external service providers from 1 July 2010 and the municipality will acquire four additional water tankers in the 2010/11 financial year and provide the service through internal resources and that 12 drivers for the water tankers will be appointed on a two year contract, thereafter they will be appointed on a temporary basis each year until the water crisis in Mogalakwena has been addressed.
- o) it also be noted that if a consumer is in arrears on his rates, levies and other services the selling of pre-paid electricity/water must be reduced to 30% of the amount paid and the balance of 70% be allocated to the arrear account until the full outstanding amount has been paid or an instalment agreement has been signed and if the consumer defaults on the instalment agreement the selling of pre-paid electricity/water again be reduced with 70% with immediate effect as well as that defaulting consumers will be prohibited from renewing their vehicle license registrations.
