**4. TOWN PLANNING: UPGRADING OF LAND TENURE RIGHTS AT REBONE – A TOWNSHIP (17/2/6/6)S**  
**(ITEM 4 AGENDA SPECIAL EC 22 JANUARY 2013)**

**RESOLVED:**

THAT

- a) the request for the consent of the Minister to declare the township of Rebone – A situated on the farm Rebone 386 – LR, Limpopo Province as a formalized township for purposes of section 2 of Chapter 1 of the Upgrading of Land Tenure Rights Act, 1991 (Act 112 of 1991) be supported.
- b) the Minister approves the Layout Plan (Plan no. “Reb-A/001” dated Sept 2012) and the Conditions of Establishment in terms of the proposed Rebone – A township.
- c) after the opening of the township register, the township of Rebone – A will be incorporated into the Greater Potgietersrus Town Planning Scheme, 1997 or its successor in title.

- d) the municipal manager, Mr Shella William Kekana, be authorized to sign all the necessary documents and the applications for the registration or opening of the township register.
