7	THAT in terms of section 75A of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) the tariffs and charges reflected in Annexure B to G attached as <u>pages 944 to 962</u> be approved for the budget year 2023/24.
8	THAT That Council takes note that NERSA has not published its annual municipal tariff guideline document that stipulates the percentage increase municipalities may levy to its electricity consumers, which means that the electricity tariff of 12.7% included will be amended later.
